At Hartlebury, the company manufacture hulls and decks to be sent to the Kidderminster plant for a full fit. Sealine currently employ

50 people on the Estate and that will increase within the next year.

Unit 131 provides Sealine with a perfect location, the building provides a large internal space with a sizeable yard and ample storage for the components needed for manufacture and site access also proves beneficial to the company's operation. A 5S manufacturing process is being installed on site to make the plant even more efficient.

Their premises at Hartlebury was ideal to develop the business with steel fabrication and design facilities on hand with space to allow the installation of systems for demonstration.

Twenty two years later, Central Weighing have both their office, production and demonstration facilities on the Estate employing 22 people and exporting systems to over 35 countries.
